- 1. **PURPOSE**: The purpose of this issuance is to establish policies for public health actions for tuberculosis (TB) care.
- 2. APPLICABILITY: This directive applies to all U.S. Immigration and Customs Enforcement (ICE) Health Service Corps (IHSC) personnel, including but not limited to, U.S. Public Health Service (PHS) officers, civil service employees, and contract personnel. It is applicable to IHSC personnel supporting health care operations in ICE-owned and contracted detention facilities, and to IHSC Headquarters (HQ) staff. This directive applies to contract personnel when supporting IHSC in detention facilities and at HQ. Federal contractors are responsible for the management and discipline of its employees supporting IHSC.

- 4. POLICY: IHSC staff implement public health actions for TB care, including a broad range of activities and interventions, to promote and protect health and prevent or mitigate infectious disease transmission. IHSC staff must follow protocols established in 05-11 G-01, Public Health Actions for Tuberculosis Care Guide: IHSC-Staffed Medical Clinics, and 05-11 G-02-G-02, Public Health Actions for Tuberculosis Care Guide located in the IHSC Policy Library. IHSC public health actions for TB include:
 - **4-1.** Intake and annual TB screening of detainees.
 - **4-2.** Evaluation and management for TB disease.
 - **4-3.** Environmental infection controls and airborne precautions.
 - **4-4.** Surveillance, reporting, and case management for TB.
 - 4-5. Medical holds and medical alerts.
 - **4-6.** Release planning and continuity of care.
 - **4-7.** Clearance for general population and transportation.

- 4-8. Contact investigations.
- **4-9.** Coordination and collaboration with local, state, and federal public health authorities.
- **5. RESPONSIBILITIES**: Refer to the guides listed in Section 6, Procedures, for a detailed description of following key roles and their respective responsibilities.
 - **5-1. Infection prevention officers (IPOs)** implement TB case management activities at field sites. When present, IPOs lead TB contact investigations within IHSC-staffed facilities.
 - **5-2. Facility healthcare program managers (FHPMs)** implement TB case management activities at field sites without IPOs. FHPMs lead TB contact investigations when the facility does not have an assigned IPO on-site.
 - **5-3. Field medical coordinators (FMCs)** liaise with PHSP Unit staff and facilitate communications and information sharing about ICE detainees with confirmed or suspected TB disease in their areas of responsibility.
 - **5-4. Health services administrators (HSAs)** ensure appropriate implementation of TB case management activities at field sites without IPOs or FHPMs. HSAs lead TB contact investigations when the facility does not have an assigned IPO or FHPM on-site.
 - **5-5.** Regional infection prevention supervisory nurses provide guidance to IHSC staff in all locations and oversee TB case management activities within their respective regions. The regional infection prevention supervisory nurses liaise with IHSC facility staff, FMCs, IHSC supervisors, and government and non-government public health and law enforcement partners.
 - 5-6. Public Health, Safety, and Preparedness (PHSP) Unit.
 - **5-6.1** The **PHSP Unit chief** provides overall supervision to the PHSP Unit and advises on public health actions for TB care.
 - 5-6.2 The PHSP Unit senior public health analyst supports data collection, data management, data analysis, and communications with government and non-government public health and law enforcement partners.
 - 5-7. The national infectious disease consultant, infectious disease advanced practice provider, and infectious disease public health analyst(s) liaise with PHSP Unit staff on public health actions for TB care.

- 10. PRIVACY AND RECORDKEEPING. IHSC maintains detainee health records in accordance with the Privacy Act and as provided in the DHS/ICE-013 Alien Health Records System of Records Notice, 80 Federal Register 239 (Jan. 5, 2015). Electronic health records are destroyed ten (10) years from the date the detainee leaves ICE custody. Retention periods for records of minors may differ. IHSC staff scan paper records into the electronic health record and destroy the paper record after upload is complete.
 - **10-1.** Protection of Medical Records and Sensitive Personally Identifiable Information (PII).
 - **10-2.** Staff must keep all medical records, whether electronic or paper, secure with access limited only to those with a need to know. Staff should lock paper records in a secure cabinet or room when not in use or not otherwise under the control of a person with a need to know.
 - **10-3.** IHSC trains staff at orientation and annually on the protection of a patient's medical information and PII.
