As the Office of Investigations (OI) moves forward in collaborating activities with other federal, state, and local government entities to support the Information Sharing Environment (ISE), all Headquarters Divisions and Special Agent in Charge (SAC) offices are reminded that data from the Immigration and Customs Enforcement (ICE) law enforcement systems (LES) is being shared to assist in the advancement of the ISE, which ultimately will help to increase the security of our nation. The ICE LES data that OI agrees to share is specific to the Memorandum of Understanding (MOU) established between the Department of Homeland Security (DHS) along with representation by ICE and the respective entity being provided the data. Specific ICE LES data being shared is identified in further detail in the below information.

- Reports relating to asylum claims

Every SAC office must ensure that all OI data within the ICE LES is coded with the correct access control information as per established OI policy and/or guidance. Any OI data that is not properly coded has the potential to be shared with entities external to DHS/ICE. Therefore, it is to the benefit of each SAC office to continually review their respective enforcement data within the ICE LES to ensure that not only is the data accurate, complete, and up-to-date, but to ensure that it is coded with the correct codes for the proper release or non-release of OI data in support of the ISE.
