SUBJECT:	287(g) Processing Guidelines

This memorandum provides guidance on the processing of 287(g) arrests in ENFORCE.

In order to more accurately track 287(g) arrest statistics, the 287(g) Program Management Office along with the Executive Information Unit has created a guide with standard operating procedures to assist 287(g) officers and supervisors in the processing of 287(g) arrests in ENFORCE. Along with the guide, several enhancements will be made to ENFORCE for 287(g) processing. These enhancements include the addition of a 287(g) specific Event Type code and 287(g) specific Landmark codes. With these enhancements and the processing procedures outlined in the guide, additional quality control over 287(g) arrest statistics will be achieved.

Please ensure that all ICE supervised 287(g) officers abide by the instructions in the guide when processing a 287(g) arrest in ENFORCE. These new processing procedures shall be followed for all 287(g) arrests occurring on or after 12:00 a.m. EST, January 1, 2008.

This quick reference is designed to guide all 287(g) officers in the correct procedures for processing of aliens. There are no other acceptable methods to process 287(g) arrests. Full processing should be completed after the subject's identity, arrest and criminal history have been verified through IDENT/IAFIS.
